Guidelines

- Blocks must be submitted measuring 12 1/2" allowing for 1/4" seam allowances (12" finished).
- Three (3) fat quarters will be provided per entry — 1 each of black, orange and white fabric.
- Each entry must include some fabric from all three (3) fat quarters
- Additional fabric(s) may be incorporated for designs needing more than three colors.
- Fabrics used must be pre-shrunk, 100% cotton.
- A \$15 entry fee will be charged per block entered.
- People are welcome to submit more than one block, as long as \$15 accompanies each entry.
- All contest entry fees go toward "Advanced FCS 4-H Scholarship"
- Contest is open to all interested persons, including OHCE members, 4-H members and volunteers, OSU and OCES employees, quilt guild members, fabric store owners, etc.
- No person entering the contest will be involved in judging entries, however may assist with aspects of the CES Centennial project such as joining blocks for a finished quilt, displaying, etc.
- Rosette(s) & a cash award(s) may be presented in each needlework category, at the judges' discretion.
- All block entries become property of Oklahoma Cooperative Extension Service.
- Contest blocks and awards will be displayed at State OHCE Meeting, July 13-15, in Norman, Okla.
- All entries should be postmarked by July 1, 2014.
